

CONDITIONS OF PROBATION

1. I will keep the peace, be of good behavior and not violate any local, state or federal laws or ordinances. I will report any arrests or citations to the Community Corrections Office within three working days.

2. I will follow my Probation Officer's instructions, be truthful and cooperative.

3. I will report to the Community Corrections Office on a schedule developed for me by my Probation Officer. I will keep my scheduled appointments.

4. I will reside at _____ and will not change my residence without notifying my Probation Officer first. Home verification will be required.

5. I will obtain and maintain regular employment and will notify my Probation Officer of employment changes. Employment verification will be required.

6. I will not use, possess or distribute unlawful drugs. I will not use alcohol beverages in excess or prior to any scheduled appointments. I will voluntarily submit to drug and/or alcohol testing.

7. I will not leave the local area or leave the Commonwealth of Virginia without permission from the Community Corrections Office.

8. I will not use possess, transport or carry a firearm or anything considered a weapon while on Probation.

9. I understand that I will remain on Probation until I am released by the Court.
